Wedding Photography Agreement

This constitutes an order for wedding photographs, albums and prints. It is understood that any and all proofs, digital files and negatives remain the property of Jeannie Tuttle Photography and may be used for advertising, display, publications, etc.

Although all care will be taken with the digital files, negatives and photographs taken at the wedding, photographer limits any liability for loss, damage or failure to deliver portraits for any reason to the return of all retainers.

It is understood that no other photographer, amateur, professional or otherwise, shall be allowed to photograph at the wedding while Jeannie Tuttle Photography and associates are working. We will not be responsible for the loss of portraits due to the interference of other photographers. Any breach of this agreement will constitute a loss of initial retainer and Jeannie Tuttle Photography will not be held liable.

Upon your signature of the agreement, Jeannie Tuttle Photography reserves the time and date agreed upon, and will not make any additional reservations for that time and date. For this reason, a retainer is required and is non-refundable, even if the date is changed or wedding cancelled for any reason.

The client shall be responsible for paying the retainer of \$100 at the signing of the agreement. The retainer shall be applied to the total which is due prior to the wedding date. No delivery of portraits will occur until all funds have been received and processed.

Prices in effect at the time of this agreement are applicable for the listed items in the wedding package chosen. Any future orders and additional items are subject to current prices at the time of the order.

Due to exclusive scheduling of your event, monies paid to Jeannie Tuttle Photography up to your wedding date and prior will not be refunded if the wedding is canceled or rescheduled. We will, however, apply the retainer to a different date if the date is available on our calendar.

In the event of great illness, act of God, death in immediate family, fire or other cause beyond our control, Jeannie Tuttle Photography reserves the right to substitute another photographer with comparable ability.

All images taken are the exclusive property of Jeannie Tuttle Photography and are protected by federal law. Any client reproducing any of the images without prior consent and release is subject to civil and criminal penalties.

Jeannie Tuttle Photography exercises great care in the handling of your images; however, in the event that we fail to comply with the terms of this contract due to any event or act outside of our control, our liability is limited to refunding any retainer paid to date.

Any changes or modification to this agreement must be put in writing and agreed upon by both parties.

Initial images will be available for viewing 4-6 weeks after wedding date; time may vary due to schedule demands.

Additional time added to each wedding package will be billed at \$175 per hour with a one-hour minimum.

All wedding packages require meals be provided to the photographer(s) and assistant at the expense of the client. The dinner meal must be provided immediately after the bride, groom and wedding party are served.

ALL participants in the wedding party MUST be ready two hours prior to the ceremony, or as specified by photographer. Failure to comply will cause specified photos to become unfeasible.

All payments for post production services must be paid in full prior to delivery of final product.

Jeannie Tuttle Photography agrees to provide all services in a professional manner, to be unobtrusive and to make every reasonable effort to arrive on time for all events.

All terms of this agreement are understood and agreed upon.
